c) Further, for the month of Apr-2024, the revised implemented Schedule on account of grid disturbance/tripping/interruptions of Biomass Generators connected at 33 KV or 132 KV voltage level of CSPTCL/CSPDCL system is pending for cross-check which will be done tentatively by the end of May-2024 in FINAL SEA report for Apr-2024."

As the same is still pending for verification therefore, it will be processed in due course of time and intimated accordingly with revised SEA.

Further, all data towards intra-state transactions **remains unchanged** in respect of Final Inter-state and Intra-state SEA for Apr-2024 issued vide above referred (10).
