Tenders received after the stipulated time/date will not be considered. Covers should in variable be super scribed "Tender for Supply and Installation of AC Along with Earnest Money deposited Rs. 4000/- (Rupees Four Thousand only) in case or Demand Draft payable in favour of The Manager (RAO-H.Q.), Chhattisgarh State Power Transmission Co. 03. When Tenders are delivered by special messenger, it should be dropped in the "Tender Box" kept in the office the Chief Engineer (SLDC) Chhattisgarh State Power Transmission Co. Ltd, Danganiya, RAIPUR 492013 (C.G.) at any working day between 10:30 Hrs. to 17:30 Hrs. Nobody is authorized to receive or grant receipt for the delivered tender. The Tender should be dropped in the tender box placed in the O/o C.E. (LD), CSPTCL, Raipur for this particular tender No. 03-02/TR/129 dtd. 27.02.19. In case, the tender is sent through post/courier, it will be responsibility of the bidder to drop/get dropped the tender in the tender box. Receipt of tenders shall not be given in any case. The tender should be dropped before or **up to 15.00 Hrs** on due date of submission. Tender box shall be sealed at **15.00 Hrs** and in no case tenders shall be allowed to be dropped **after 15.00 Hrs**.
04. **VALIDITY:** - Full descriptive particulars and complete specification should accompany the tender. Offers should be kept open for acceptance for at least three months from the date of opening. Those who do not agree for a validity of 3 months will do so at their own risk and no request for extension will be intimated from this office, However, due to circumstances beyond control, the bidders will be allowed to extend validity but they shall not be permitted to revise their rates, offer any rebate or concession while extending the validity which may materially result in any reduction/increase in the computed price of their original offer.
05. The bidders would be bound by the terms and conditions and specification as given therein after and in the attached schedule.
06. The Trans Company reserves the right :-
 - i) To reject any or all tenders or to accept any tender considered advantageous to the Trans Co. whether it is lowest tender or not; and
 - ii) To split the quantities against the tender on more than one firm for the same items/works. No reason will be assigned by the Trans Co. for these and will be binding on the bidders.
07. In case of correction done in the tender, the bidders should initial the same otherwise the tenders may not be considered.
08. Telegraphic offers will not be considered.
09. All the bidders shall essentially indicate the break up of prices as shown in the tender from. In case any of the charges are not included in the quoted price, the same shall be clearly shown as "Extra" indicating specifically the rate/scale of such charges.

 - ii) Fully owned State/Central Government units will qualify this exemption only if 100% shares are held by State/Central Government concerned for which documentary evidence must be made available.
15. **SUBMISSION OF EARNEST MONEY DEPOSIT** :-
A separate envelope containing the earnest money or a certificate in support of claim for exemption from this should be attached with your offer duly super scribed either earnest money deposit in appropriate form against "Tender specification No. 03-02/TR/129. 16. **FORFEITURE OF EARNEST MONEY DEPOSIT** :-
It should be clearly understood that in the event of bidders failing accept and execute the telegraphic and detailed orders, if it is placed within the validity period of the offer, the full amount of earnest money will be forfeited and Trans Company decision in this respect will be final and binding on the bidders.
17. **FORFEITURE OF EARNEST MONEY DEPOSIT** :-

21. **PERFORMANCE GUARANTEE / DEFECITIVE SUPPLIES**:- If during the course of 12 months from the date of completion of work, any of the supplied and installed goods is found defective in Materials or workmanship or develop defect in service, the same will be replaced and attended by the Contractor on free of all charges.
22. **SECURITY DEPOSIT**:- The contractor will have to deposit 10% amount of the contract award towards SD. SD shall be deducted from contractor's bill. The SD can also be submitted in form of FDR / TDR favoring "**The Manager (RAO: HQ), CSPTCL, Raipur**". The security deposit amount will be released after 12 month from the date of satisfactory completion of the work & performance of the work certified by the concerned EE. No interest shall be paid by CSPTCL on security deposit in case of non- fulfillment of contractual obligations by the contractor, the security deposit shall be forfeited
23. **PAYMENT**: - 100% payment shall be made after satisfactory completion of complete work within a month. No interest shall be payable in case of delay in payment.

24. **INCOME TAX DEDUCTION**:- Deduction towards income tax (on labor charges) will be made from the contractor bill as per rules in force..
25. **PENALTY**:- If the contractor / renderer fails to complete the work ordered within the specified time schedule, the penalty will be levied @ 0.5% per week or part thereof up to a maximum of 10% on the value of un completed portion of the work ordered on the Contractor.
26. **INCREASE/DECREASE IN QUANTITY**:- The Trans. Co. reserves the right to increase/decrease the quantity up to 50%.
27. **CONSIGNEE**: - The **Executive Engineer** O/o CE (SLDC), CSPTCL, Raipur.
28. **NODAL OFFICER**: - The **Executive Engineer (E&M)** O/o CE (SLDC), CSPTCL, Raipur will be nodal officer for supervision of work related to the installation and issue of work completion certificate.
29. **SUBMISSION OF BILLS**:- All the bills shall be submitted in Triplicate to The Executive Engineer O/o CE (SLDC), CSPTCL, Raipur.
30. **Tax**:- The rate should be FOR destination and should include all taxes, duties, etc GST. GST shall be indicated separately.
31. All T & P items and required material will be arranged by the contractor/supplier for completion of work.
32. If any accident occurs during the course of working full liabilities lies on the Contractor and no compensation will be admissible by the Trans Co. The work is to be done in the supervision of the representative of the Trans Co. only.
33. Any damage or losses occurs to the trans. Co. property during the work that will be recovered from the contractor's bill.
